1. Completed Application

APPLICATION FEE: \$100.00 U. S. (Note: 1. e.)

- a. Page 1 – The following Items must be completed:
 - i. Email Addresses for both parents (if available)
 - ii. Student email address.
 - iii. Home Address – Necessary for the I-20
 - iv. Name, Phone Number, Address for Contact Person in the U.S. (If available, ie. Relative, family friend)
 - b. Page 2 – Admission Agreement
 - i. Parent & Student to initial each line (Acknowledges understanding and agreement for policies and procedures of Antelope Valley Christian School).
 - ii. Parent & Student signature at bottom of page.
 - c. Page 3 – Parent Questionnaire
 - i. Please complete fully and place signature at bottom of page.
 - ii. Parent Recommendation – Please feel free to attach a letter that may give more detail about your child – Not required, but appreciated
 - d. Page 4 – Student Questionnaire
 - i. Please complete fully and place signature at bottom of page.
 - ii. Student Essay – Not required, but appreciated.
 - e. Page 5 – Credit Card Authorization for \$100 application fee. Only VISA and MASTERCARD are accepted. \$100 application fee may also be paid by Cashiers Check.
- 2. Proof of Birth – Birth Certificated or Family Registry, Household Registry** is required to process application.
- 3. Complete Transcripts/School Records** – Please provide Copies of all school records, from Elementary (Kindergarten) through most current grade level. These records must be certified translations into English.
- 4. Optional TOEFL Score:** All incoming students will be placed in the ESL Program for one academic year, unless a TOEFL score of **78** (or higher) **iBt** is submitted at time of application. All returning students will be placed in ESL Program until a TOEFL score of **78** (or higher) **iBt** has been achieved..
- 5. Copy of Passport** – Necessary for confirming spelling of name and date of birth.
- 6. Health records** – To include list of any necessary medications with translations in English.
- 7. Copy of Immunizations/Inoculations.**
